- Manages and organizes the accounting teams / accounting activities in Belgium and the Netherlands into one BeNe accounting team, in analysis and reconciliation of accounts, financial reporting and optimization of processes.
- Works closely with the CFO and manager controlling BeNe

The ideal candidate possesses leadership capabilities, solid operational and technical accounting background and works proactively to drive results. This person has a capacity to investigate and organize, is solution-oriented and can work (partly remote) with experienced and collaborative accounting teams.

Responsibility;

- Lead the accounting teams in Belgium and Netherlands (activities, objectives, motivation, coaching, appraisal).
- Divide and coordinate all accounting activities within the teams to ensure efficient and effective accounting activities, and secure the required financial integrity, expertise and continuity.
